## Dropping a Class

Failure to do so may result in a grade of “F” in that class.

Oct. 26-28, 2015	<b>Group 1: Fully Matriculated State Mandated Special Populations</b> Fully matriculated active-duty military, CalWorks, EOPS, DSPS, Foster Youth and Veterans students.
Oct. 29 – Nov. 15, 2015	<b>Group 2: Fully Matriculated Students</b> Fully matriculated continuing, new and returning students.
Nov. 16-29, 2015	<b>Group 3: Students without Priority Enrollment</b> Non-matriculated continuing students, students with 100+ degree applicable units district wide, continuing students not in good standing, 2nd semester academic and/or progress probation, new and returning students applying after cutoff date to assign priority registration appointments.
Nov. 30, 2015	<b>Group 4: Students Enrolled in Grades K-12</b> Continuing, new and returning K-12 students, K-12 students who applied after the cutoff date to assign priority registration appointments.

**\*Late adds will not be permitted.**  
Students cannot add, transfer or change basis of grading to audit after this date.
