ADMISSION REQUIREMENTS

- **Financial Support** – Provide proof of the ability to pay non-resident tuition and enrollment fees. Currently the non-resident tuition is \$ 251 + \$ 46 per unit, plus living and personal expenses for one year.
- **English Language Requirement** – Student must have full English language proficiency. The following methods may be used to show proficiency:
 - Original TOEFL score 45 IBT, 133 CBT or PBT
 - Original IELTS score 4
- **Academic Records** - Provide **original** transcripts from high (secondary) school completion and **original** diploma. All records which are not in English must be translated into English.
- **Passport and Visa Information** - Provide copies of your passport, visa and I-94
- **One Passport size photograph**
- **Application Processing Fee** – A non-refundable \$ 50 application fee must be included with the application package. **.NOTE:** No documents will be reviewed until the processing fee is received. Fee is accepted by money order or cashier's check payable to Los Angeles Valley College and in U.S. dollars. No personal checks or credit cards accepted.

ESTIMATED EXPENSES FOR NON-RESIDENT STUDENTS

As non-residents of California, International students are required to pay a non-refundable \$50 application fee, non-resident tuition and SEVIS fees. International students are not eligible for financial aid.

CONCURRENTLY ENROLLED F-1 VISA APPLICANTS

If you wish to concurrently enroll in a class at LAVC while attending another school, you must submit the following documents to the International Students Office **for each semester you wish to enroll.**

- **Admission Application** - Available at the International Students Office
- A non-refundable application fee of **\$ 35** must be included with your application. Fee is accepted by money order or cashier's check payable to Los Angeles Valley College. No personal checks or credit cards accepted.
- Provide a copy of I-20 (both pages), valid passport, visa, and I-94. **NOTE:** It is the student's responsibility to provide copies of all required documents prior to submitting the application.
- An **original letter** from your current Designated School Official (DSO) or counselor verifying your status and the class(es) you wish to take. DSOs and/or Counselors may email the concurrent letter directly to LAVC at intlstud@lavc.edu. The letter must be addressed to Los Angeles Valley College, including units approved, and the semester/year.
